# OF THE MATES CREEK DISTRICT PRIMITIVE BAPTIST ASSOCIATION, HELD WITH THE RACCOON CHURCH

FRIDAY MORNING—September 1, 1961

The Association was called to order by the Moderator. Prayer by Elder Teddy R. Ball.

The Introductory was preached by Elder J. H. Blackburn; no special text.

Moved and seconded that Elder Fonso Justice, Teddy R. Ball and Dan Adkins be appointed to write an article to be printed in the Minutes in answer to article 13, page 4 of the 1960 Minutes of the Washington Association.

They wrote the following:

#### TO WHOM IT MAY CONCERN:

Be it known, that we as a special committee to wit: Elders Teddy R. Ball, Fonso Justice and Dan Adkins were appointed to answer the charge against the Mates Creek Association concerning the doctrine of regeneration.

We very deeply regret the misunderstanding on this vital question. We specifically report a denial of charge of Washington Association at their 1960 session that we preach or believe that the whole man is born again. Neither do we believe that the evil spirit in man is born of the Spirit of God.

We further report that Mates Creek Association believes that a sinner receives in regeneration the Spirit of God. The evil spirit in man is not born again.

We believe the individual after the new birth remains mortal, corruptible and the mind of the flesh; that in his flesh dwells sin and the evil spirit.

We believe we that are regenerated possess two natures: namely, the nature of Adam and the divine nature of God.

That by possessing divine nature we have the law of God, the mind of the Spirt and Christ the hidden man of the heart.

That by retaining the nature of Adam we possess the law of sin, the mind of the flesh and the evil spirit.

We believe that we through the Spirit of God, which we received in regeneration should mortify the deeds of the flesh in that we should not obey the nature of corruption and the evil spirit of the flesh.

We believe that we will reach a state of perfection in the resurrection of the corporeal dead, when our bodies are changed from mortal

to an immortal body.

The churches of the Mates Creek Association are hereby advised to admonish all their Elders from each respective church that it will be considered a violation of Mates Creek Association to preach:

1. That the whole man is born again.

2. That the evil spirit is born of the Spirit of God.

Moved and seconded that the Association be adjourned until

9:00 o'clock Saturday morning.

- C. Examined the bill of items for Saturday and agreed the Association should carry on its work in the usual manner.

#### CIRCULAR LETTER

Sept. 1, 1961; Rt. 5, Louisa, Ky. Dear Brethren that may compose the Mates Creek Association of Primitive Baptists, when met with Raccoon Church, Raccoon, Ky., I submit this for a Circular Letter.

#### ATONEMENT

Atonement, Reconciliation, Expiration, Satisfaction, atonement, to make as one.

We were all like sheep gone astray all out of the way. But the Lord laid on Him the iniquity of us all. He bore the iniquity of the sheep. He laid down His own life for the sheep, not the goats. He suffered for the sins of all the elect. (All of them past, present and future.) The just for the unjust, that he might bring us to God. The words "world," "all," "many" are general terms and mean all of a class or all His elect. He tasted for every man; by the obedience of One many be made righteous. This is the many, or every man He tasted death for. The many sons brought to glory, the brethren, the sanctified, the church, sheep. Jesus says, "I pray for them, I pray not for the world." He did not pray for all the race then, but for them which "Thou hast given Me." Now brethren, if He atoned for all the race, He evidently would have prayed for all the race. A man that contends that He atoned for all the race or for universal atonement does not believe that Christ made any atonement at all. Every one must make his own atonement by his own suffering, and be his own savior. But Christ bore the sins of all that was given Him in a covenant of grace, before the world began.

All the sins of all His people, all their guilt was expiated—perfect satisfaction for all their sins was made, and He bore them in His own body.

No sins left, no guilt for the sinner to atone for. If so, hell would be the doom of all the race. He blotted out as a thick cloud their sins. Now if their sins are blotted out, the sheet is clean, and nothing stands against them to condemn them. Jesus Christ was the Surety of His people. He as Surety assumed the entire debt and paid it all.

All the suffering due to His people, He suffered for them in His own body. St. John 10, 11. I am the good Shepherd: the good Shepherd giveth His life for the sheep. St. John 10:14: I am the good Shepherd, and know My sheep and am known of Mine.

15th verse: As the Father knoweth Me, even so know I the Father; and I lay down My life for the sheep. This is what Jesus did for the elect or His sheep.

Lets talk about some of the musts we have written. Jesus, while talking to Nicodemus told him to Marvel not that I said unto thee, Ye must be born again. Dear Brethren, there is no other name given whereby we must be saved. So you see that His elect people must be saved. Baptists have taught all along, first by Christ and the Apostles, and on down through time until now and is yet taught by Primitive Baptists that the atonement is for the elect only.

He purged their sins, perfected forever, by one offering, a special people. Every atonement (offering), under the law was for a special people. It is according as He, God, has chosen us in Him (Christ) before the foundation of the world. And blessed us with all spiritual

blessings in Christ. The Atonement of Christ represent all chosen in Him and given to Him in the covenant of grace. He paid all their debt on the cross. This chosen number is the "world," that He was the propitiation for their sins, and whose sins He bore and put away to be remembered no more. This is the many He made righteous by His obedience, the "Church," "the sanctified," the sons brought to glory. The Baptist in the year 860 believed in unconditional election and special atonement. That is what we "Old Baptists" believe today. God bless you, my dear brethren, I have written this in love to all.

Ses Control

1. This Association shall be calld Mates Creek District Primitive

Baptist Association.

2. The Association shall be composed of members chosen by the different churches in our union and duly sent to represent them in the Association, who shall be members whom they judge best qualified for that purpose, and producing letters from their respective churches certifying their appointment, shall be entitled to seats.

3. In the letters from the different churches shall be expressed their membership in full fellowship, those baptised, received by letter, dismissed by letter, excluded and deceased since the last As-

sociation.

- 4. The members thus chosen and convened shall have no power to lord it over God's heritage nor shall they have any clerical powers over the churches, nor shall they infringe on any of the internal rights of any church in this union.
- 5. The Association when convened, shall be governed by a regular and proper decorum.
- The Association shall have a Moderator, Clerk and Treasurer, who shall be chosen by the suffrage of the members present.
- 7. Newly constituted churches may be admitted into the union who shall petition by letter and messenger, and (if found upon examination to be orthodox and orderly), shall be received by the Association, and manifested by the Moderator giving the right hand of fellowship.
- 8. Every church in the union shall be entitled to a representation

in the Association.

- 9. Every query presented by any church to the Association, being first debated in their own church, shall be taken up by the Association.
- 10. Every motion made and seconded shall come under the consideration of the Association, except it shall be withdrawn by the member who made it.
- 11. The Association shall endeavor to furnish the churches with Minutes of the Association, the best way and method for effecting that purpose shall be at the discretion of future Associations.
- 12. We think it absolutely necessary that we should have an Association fund for defraying the expenses of the same, for the raising and supporting of which we think it the duty of each church in the union to contribute such sums voluntarily as the y think proper, and send it by the hands of their messengers to the Association, and those monies thus contributed by the churches and received by the Association shall be deposited in the hands of the Treasurer, who shall be accountable to the Association for all monies received by him, and pay out of the same according to the Association.
- 13. There shall be an Association book kept, wherein the proceedings of every Association shall be regularly recorded by the Secretary chosen for that purpose, who shall receive compensation for his trouble.
- 14. The Minutes of the Association shall be read and corrected, if need be, and signed by the Moderator and Clerk before the Association arises.
- 15. Amendments to this plan or form of government may be made at any time by majority of the union when they deem it necessary.
- 16. The Association shall have power: (1) To provide for the general union of the churches. (2) To preserve inviolably a chain of

communication among the churches. (3) To give the churches necessary advice in matters of church difficulty. (4) To inquire into the cause why the churches fail to represent themselves at any time in the Association. (5) To appropriate those monies by the churches contributed for an Association fund to any purpose they may think proper. (6) To appoint any member or members by and with their consent to transact any business they may see necessary. (7) The Association shall have power to withdraw from any church in this union which shall violate the rules of this Association, or deviate from the orthodox principles of religion. (8) To admit any orderly minister of our faith and order to a seat in the Association. (9) The Association shall have power to adjourn themselves to any time or place they may think most convenient to the churches of the Association.

#### ARTICLES OF FAITH

- 1. We believe in one true and living God, who is the Creator, up-holder, and righeous disposer of all things; and that He is self-existent, independent, omnipotent and eternal.
- 2. We believe that Jesus existed in His mediatorial Person as the head and life of His body, the church, from everlasting.
- 3. We believe the doctrine of eternal, personal and unconditional election; that the elect, or church, is and was and shall forever remain His body and fulness, and their spiritual life is hid with Christ in God.
- 4. We believe in the doctrine of total depravity of human nature and that recovery from that condition is wholly and exclusively by the sovereign, free and unmerited grace of God.
- 5. We believe the atonement made by Christ was full and complete and exclusively for the elect, or heirs of promise.
- 6. We believe the doctrine of God's predestination in every sense as the Bible teaches it.
- 7. We believe that all the elect vessels of mercy, chosen in Christ before the foundation of the world, shall be called, regenerated and sanctified by the regenerating power of God's grace, and shall ultimately enjoy heaven and immortal glory.
- 8. We believe that there will be a resurrection of the bodies, both of the just and the unjust, and the happiness of the righteous shall be eternal and the punishment of the wicked sall be everlasting.
- 9. We believe that baptism and the Lord's Supper are ordinances of Jesus Christ, and that true believers are the subjects, and the true mode of baptism is immersion, foot-washing an example.
- 10. We believe the scriptures of the Old and New Testaments as translated under the reign of King James, are a revelation from God, inspired by the Holy Ghost, and that the New Testament is the standard of faith and the only authorized rule of practice to the church of God under gospel dispensation. We therefore consider ourselves solemnly bound by our allegiance to the King of Zion to reject, disclaim and disfellowship all modern and ancient religious institutions or societies of which we have neither precept nor example in the New Testament.

#### RULES OF DECORUM

1. The Association shall be opened and closed by prayer.

2. A Moderator and Clerk shall be chosen by the suffrage of the members present.

3. Only one member shall speak at a time, who shall rise from his

seat and address the Moderator when he is about to speak.

4. The person thus speaking shall not be interrupted by any except

the Moderator until he is done speaking.

5. He shall strictly adhere to the subject and in no wise reflect on the person who spoke before so as to make remarks on his slips, failings and imperfections, but fairly state the case and matter as nearly as he can as to convey his ideas.

6. No person shall rise and speak more than three times on one

subject without liberty obtained from the Association.

7. No person shall abruptly break off or absent himself from the Association without liberty obtained from it.

8. No member of the Association shall have liberty of laughing during the sitting of the Association, nor whispering in time of public speech.

9. No member of the Association shall address another in any other

term or appellation but the title of "Brother."

10. The Moderator shall not interrupt any member in a speech or prohibit him from speaking until he gives his light on the subject, except they break the Rules of Decorum.

11. Names of the several members of the Association shall be enrolled by the Clerk and called over as many times as the Association

may require.

12. The Moderator shall be entitled to the same privilege of speech as another member, provided the chair be filled, and he shall have no vote except the Association be equally divided. In that event he shall give the casting vote.

13. Any member who shall wilfully or knowingly break any of these

rules shall be reproved by the Association as they think proper.
